

Objective 2: The functions of a YAG

Functions of a YAG



- Support and advice
- Networking and information exchange
- Sharing of resources and best practice
- Avoiding duplication
- **Reflective practice**
- Challenging others and highlight issues of concern in an area
- Planning activities collectively

The scope and limitations of YAGS

What are YAGs NOT and what can they NOT be expected to be?

Like youth work, YAGs can form a piece of the overall puzzle, but alone they cannot be expected to 'resolve youth poverty' for example



However, YAGs CAN <u>amplify</u> the impact of youth services in an area as a result of greater coordination, improved information and greater access to resources for local service providers

The scope and limitations of YAGs

In order for YAGs to reach their potential impact, this is what they should not be expected to do;

- They should not be regarded as a tick box exercise.
- They are not simply a talking shop.
- They are not simply a mechanism for reporting to funders on the achievement of outcomes.
- They are not simply a vessel for power holders to disseminate instruction to community level partners.

Instead they can be regarded as;

 A place for local service providers to plan and discuss the delivery of local youth activities.

• A place for partners to share information related to these issues.

3 core aims of YAGs

Strengthening local services

Creating networks

Challenging social exclusion by promoting equality
